#### **STF Overview**

- Special Transportation Funds (STF) and Federal Section 5310 help fund service for seniors and/or persons with disabilities
- TriMet is the designated agency for this region to distribute
- STF Advisory Committee (STFAC) advises the TriMet Board on the priorities for STF
- Funds are for entire tri-county area



### **STF Program Administration**

- TriMet is responsible for
  - Coordinating the grant and planning process
  - Coordinated Transportation Plan Update
  - Distribution of STF/5310 funding

# Coordinated Transportation Plan (CTP)

- Must meet federal and state requirements for the region to receive funds
- Updated every 4 years
- Developed in consultation with STF Advisory Committee (STFAC)

  - Stakeholder and STFAC outreach

- Draft finalized by STFAC expected June 3, 2016



### **Existing Transportation Services**






#### **Service Guidelines**

- Defines aspirational service levels
- Varies based on
  - day of week and time of day
  - nearby fixed-route service
  - size of the community

## Needs Assessment: Demographics and Demand



#### **Priorities & Actions**

- 3 tiers based on urgency and available capacity & funding
- Highlights of actions:
  - Create STFAC subcommittee to implement actions
  - Greater focus on tracking performance
  - Maintain services and capital replacements
  - Encourage use of fixed-route service
  - Manage demand for ADA service
    - Trip screening for "conditionally" eligible LIFT users
    - Sidewalks and crossings for access
    - Participating in land use decision-making

#### Priorities & Actions – cont'd

- Provide coordinated and updated information on transportation options region-wide
- Strong coordination, collaboration, and innovation
  - Regional E-fare participation
  - Analyze Hop Fastpass data to improve regional connections
  - Explore rideshare, trip chaining, and partnerships with TNCs
- Seek funding opportunities to:
  - Fill gaps in service and meet inspirational service guidelines
  - Create Community/Job Connectors shuttle services



#### **Finance**

- 5310 funding
- STF funding
- Identified need gaps
  - Needs were identified regardless of available funding so state and others would be more aware of complete needs
