Subject: August 2016 Monthly Performance Report

The monthly systemwide ridership increased 1.1% in August (Bus was down 2.1%, whereas MAX, LIFT/Cab and WES were up 5.8%, 6.2% and 9.5% respectively) compared to prior year's level. This month there were 2 scheduled weekdays more than last August. The two week closure at Rose Quarter for MAX track repair impacted ridership in August.

- 1. Weekly system rides decreased 2.0% in August compared to prior year's level. Weekly boardings declined 5.6% on buses, and 0.1% on WES, however increased 0.5% on LIFT/Cab and 3.2% on MAX.
- 2. Weekday fixed route boardings were 304,640 in August, 2.5% below the prior year's level. Boardings decreased 5.9% on bus and 0.3% on WES, but increased 2.8% on MAX. Weekend ridership decreased 3.9% on buses, but increased 5.1% on MAX.
- 3. The five MAX lines averaged a total of 122,605 weekday, 89,800 Saturday, and 72,900 Sunday boardings in August. Weekday ridership on each of the five MAX lines averaged 58,700 on the Blue Line, 22,200 on the Red Line, 12,305 on the Yellow Line, 19,000 on the Green Line, and 10,400 on the Orange Line. Total MAX ridership increased 12.1% during peak and decreased 1.3% in off-peak periods, resulting in a 2.8% weekday ridership increase in August. Total weekend ridership increased 4.3% on Saturday and 6.1% on Sunday, leading to a 3.3% increase in weekly MAX rides in August.
- 4. Weekday <u>bus ridership</u> decreased 5.9% in August, with declines in peak of 5.3% and 6.2% in off-peak time periods. Overall weekend boardings decreased 3.9%, resulting in a 5.6% decline in weekly bus rides. Weekly boardings decreased 5.3% on frequent routes, and 5.9% on non-frequent routes. Bus weekday ridership decreased on average of 4.0% per month since the decline began in April 2015.
- 5. WES averaged 1,835 daily boardings in August, flat compared to the prior year's level. In August, WES operated with 68 late trains, 7 out of service trains, zero missed pullouts, and one vehicle mechanical failure, resulting in a 89.7% of trips made on time. Heat related issue had a significant impact on WES on time performance. WES train is considered ontime if it arrives at the destination platform (Beaverton TC to Wilsonville) within 4 minutes of the published arrival time.
- 6. Weekly <u>LIFT/Cab</u> boardings increased 0.5% in August. Weekday and weekend boardings also increased 0.4% and 1.0% respectively, compared to prior year.
