On weekdays, operate until approximately 9:30 p.m. On weekends, operate hourly service from approximately 7:00 a.m. to 7:00 p.m. Discontinue Line 19 service south of SW Jefferson and Columbia. The SE Woodstock segment of Line 19 to be taken over by Line 4. The SE Duke segment and service to Mt.
